# 2) WATER CONSERVATION PROGRAM AND POLICY RECOMMENDATION

Assistant Director of Public Works Services Trish Rhay and Planning & Research Analyst Michelle Tse provided comment.

### A. Groundwater Wells

- Wells are complete and sampling/testing is taking place.
- Sampling and reporting to the Department of Drinking Water (DDW) is taking place; conveyance to the Treatment Plant will occur once DDW approves.

### **B.** State Water Resources Control Board Update

- Drought regulations extended through January 2017.
- Water use restrictions remain in effect.
- Local Self-Certification Target replaces mandated percentage reduction target.
  - Must be within Board's parameters
- Goal of 20 Percent reduction in per capita water use by year 2020 remains in place.

### C. Rate Structure

- The rate structure process will begin once the Comprehensive Operational, Organizational and Financial Audit of the Water System is complete.
- Provide clear message concerning penalty surcharge suspension and new water rates when presenting to City Council.
  - o Provide high level of education and outreach concerning new rates.

## D. Self-Certification Target

- Based on 3–Year Water Supply during drought conditions.
- Contingent upon MWD water supply.
- Due June 22, 2016; if the City does not submit Target, it defaults to 32%.
  - Staff to bring Target to City Council June 21, 2016.

## E. Next Steps

- The City needs a long-term sustainable water efficiency program.
- Staff will recommend suspension of Penalty Surcharges and development of a fine/fee structure for excessive/unreasonable use.
- Promotion of water efficiency as daily way of life.
